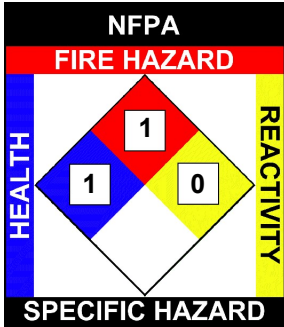

### 3 COMPOSITION/INFORMATION OF INGREDIENTS

### 4 FIRST AID MEASURES
